



Guaranteed Registration

Thank you for joining TeamCCF on behalf of the Cholangiocarcinoma Foundation!
Please read, review, and initial the Waiver and Commitment Contract. As a TeamCCF member in the 2023 Bank of America Chicago Marathon, I understand and agree to the following:

Fundraising Requirements – please initial each statement

___ As a TeamCCF member I will set a minimum fundraising goal of \$1,250 if I sign up prior to the close of the Marathon application of November 17, 2022 or \$1,750 if I sign up after November 18, 2022 to support all individuals affected by cholangiocarcinoma. I will do my best to achieve the minimum amount.

___ I understand that TeamCCF is an important fundraising initiative of the Cholangiocarcinoma Foundation, and if I run in the 2023 Bank of America Chicago Marathon and my best fundraising efforts do not result in at least \$1,250/\$1,750 being raised, as stipulated by the 2023 Bank of America Chicago Marathon, the Cholangiocarcinoma Foundation is authorized to charge any shortfall to my credit card appearing on the bottom of this waiver.

Fundraising Deadlines

___ I understand that 75% of the fundraising minimum will be due by September 18, 2023.

___ I understand that I am making a binding commitment to raising 100% of the funds by the deadline of October 6, 2023.

General Requirements

___ Cholangiocarcinoma Foundation guaranteed entries cannot be deferred.

___ Costs for registering to run in the event, \$230/\$240 are the responsibility of the registered runner. Registration forms must be completed by the participant and are separate from any fundraising-related forms.

___ Runners who have exceeded their fundraising minimum goal by \$500 by October 6, 2023 will have their registration fee minus taxes reimbursed to them by the Foundation as a reward for achieving their goal.

___ Runners who have not met their 75% fundraising goal by September 18, 2023 will have their bib pulled from packet pick up AND will be required to have their credit card charged in the full amount of the shortfall.

___ Minimum fundraising amount must be guaranteed with a credit card at the time of registration. If the runner has not met the fundraising minimum by October 6, 2023, the credit card on file will be charged the shortfall.

Injury Clause

___ In the event that I must withdraw from the race for any reason, I understand that I am still responsible for paying the FULL minimum fundraising amount.

Bank of America Chicago Marathon Requirements **please initial below statement**

- Runners must be 16 years or older on October 8, 2023
- The Chicago Marathon has a maximum race day finish time of six and a half hours (6:30:59). The Marathon course will reopen to the public on a rolling schedule based on this time limit.
- The sale and/or transfer of race bibs is strictly prohibited.
- Entries are non-refundable, non-transferable and may not be donated to future years.
- Charity entries may not be deferred for any reason, unless otherwise specified by the event.
- All participants are required to pick up their own participant packet and must show a government issued photo ID at the Abbott Health & Fitness Expo. Participant packets may not be picked up by anyone other than the runner. There is no race day packet pick up option.
